Hello Middlebrook(s) Family. I sincerely hope this February 2019 MFA Newsletter finds you healthy and happy. This MFA Newsletter contains another Middlebrook Last Will and Testament from the early 1800s. While preparing the Will of Isaac Middlebrooks for publication, I became aware that parcels of land were being transferred; however, there were no descriptions per the Public Land Survey System currently used in the United States. This land identification system was originally proposed by Thomas Jefferson who wanted not only to reward the Revolutionary War Soldiers for their services by giving them parcels of land but also to generate revenue for the nation by selling parcels of land. The system involves a Section (a square tract of land one mile by one mile containing 640 acres) within a Township (36 sections) within a Range (assigned by measuring east or west of a Principal Meridian) affording a land description such as NE ¼ of Section 2, Township 4N, Range 8W. Obviously, Jefferson felt the need for a consistent manner of labeling land. However, first the land had to be surveyed, a process that continues to this day in parts of Alaska.

Meanwhile, many of our Middlebrook ancestors were on the move across America. Beginning in 1783, a man living in Georgia could be granted 200 acres of land on his own "head-right" and fifty more acres for each additional family member — up to 1000 acres. However, the land descriptions were often vague and based on landmarks and other residents. An example might be 50 acres beginning at the north cemetery, continuing past the Smith property up to the north bank of the river marked by a big rock. Our PLSS (Public Land Survey System) was far from perfect.

Here's my point: Land case entry files afford genealogists a wealth of information. Being aware of different "styles" of land descriptions and the geographical history of our family may be beneficial in our research. After all, Judy Martz (former governor of Montana) said, "Everything has to do with geography." Most of all, I continue to marvel at the tenacity of our ancestors who struck out across our nation to forge new farms, homes, and places to call their own, meandering from one Section/Township/Range to another and ultimately bringing each of us to our geographical location today.

WE MEET AGAIN



WILL OF ISAAC MIDDLEBROOKS MORGAN COUNTY, GEORGIA

Dated 10 July 1819 Morgan County State of Georgia

To Wit: In the name of God, Amen. I, Isaac Middlebrook, being in perfect mind and memory this 10th day of July in the year of our Lord Anno Domini One Thousand Eight Hundred and Nineteen do make this my Last Will and Testament in manner and form following:

- 1st, I will my soul to Almighty God and my body to the ground.
- 2nd, I will that my just debts be paid and fully satisfied within convenient time after my decease.
- 3rd, I lend to my dear wife all my land and my four negroes, namely Cholly, Sarah, Jesse, and Jim, and my three horses remain with all the plantations utensils and so much of my present crop as will be sufficient to serve her and family together with the rest. I lend her two beds and furniture and all my cattle and hogs which I am in possession of to enjoy the land during her natural life or widowhood, but she is not to waste or willfully destroy or embezzle any part thereof, but she is not to be interrupted from enjoying the land. But

if my wife should marry in that case, I lend her only a child's part and at her death for the said part to return to my estate to be divided as is hereinafter mentioned.

- 4th, I give and bequeath to my son, Isaac Middlebrook, Junior, the sum of five dollars to him his heirs and assigns forever.
- 5th, I give and bequeath to my daughter, Jinny Hayes, Deceased, her husband and assigns forever, the sum of twenty-five dollars.
- 6th, I Will and Desire that my three daughters, Fanny Thompson, Thaney Wade, Polly Middlebrooks should have the following sum to make their parts equal to the rest of my children, that is to say, to Fanny, twenty dollars, to Thaney, fifteen dollars, and Polly, twenty dollars which sums are to be paid as soon as my Executors can accumulate money for this purpose after paying my just debts. All the balance of my property which is not herein mentioned I wish my Executors to sell as soon as they think proper and distribute to the use herein mentioned and after the death of my wife or if she should marry, then the property which I have lent her I wish my five children to all have an equal part, that is to say, Leah Chany, Elizabeth Chany, Fanny Thompson, Thany Wade, and Polly Middlebrooks, respectively. All my goods and chattels above mentioned and any case I Will they should be distributed so as to make my five children all equal shares, them and their heirs, excepting Fanny Thompson, I give and bequeath her part to her assigns, the heirs of her body forever.

Lastly, I nominate and appoint my four trusty friends, Tapley Hamon, Elizabeth Middlebrook, Martin P. Spark, Geavy Harris, and Ambrose Petty to be the sole Executors and Executrix of this my Last Will and Testament hereby revoking all other Wills and publishing this to be my last.

Witness my hand and seal the day and date above written.

Signed, sealed and delivered in the presence of John Daniele, Carter W. Sparks, and John Hardeman.

/s/ Isaac Middlebrook No probable Date given on copy (Copy is poor)

Note: Isaac Middlebrook died in 1823 in Morgan Co., GA. Later after his death, his widow

Married Jeremiah Boggess.

****Dale's note:

I did retype this document Jean Shroyer sent to me in order to provide a better publication format. However, I did maintain original spellings and punctuation. Note that "Middlebrook" and "Middlebrooks" are used interchangeably in some places. Also, there is mention of the "plantation's" utensils and crop but no land description. I am assuming that "all of my land" (item 3) was the "plantation."

John Middlebrook's Will (published in the November 2018 MFA Newsletter) stated that certain "properties" be *given* to his wife upon his death and divided between his sons upon her death. Notice that Isaac's Will uses the word *lend* regarding what he intended for his wife to have and came with some additional directions. I thought that was interesting.
